**Dr. Lisa A. Owens-Jackson**, CPA, became the Chairperson of the Department of Accounting and Finance at North Carolina A&T State University on July 1, 2019. She has served as the Associate Dean of the College of Business and Economics at North Carolina A&T State University for four years. Dr. Owens-Jackson was recognized as the recipient of the 2017 North Carolina Board of Governors Award for Excellence in Teaching. She is a Certified Public Accountant in Virginia and North Carolina. Dr. Owens-Jackson received her Ph.D. from Oklahoma State University in Stillwater, Oklahoma in 2001. She has a BS degree from North Carolina A&T State University and MA degree from The Ohio State University. She has been an Associate Professor in the Department of Accounting and Finance at North Carolina Agricultural and Technical State University since 2009.

She teaches both financial and managerial accounting in the undergraduate, MBA, MACC programs. Her research concentrates on accounting education and the use of financial and managerial accounting information in governance and decision making. She has presented at the European Accounting Association Congress, the American Accounting Association Annual Meeting, the Institute of Management Accountants National Conference, the Lean Accounting Conference and many other regional conferences. She has published in the *Academy of Accounting and Financial Studies Journal*, *American Journal of Business*, *CPA Journal*, *Strategic Finance*, *the Journal of Accountancy*, etc.

She is a member of American Institute of Certified Public Accountants (AICPA), the American Accounting Association (AAA), the National Association of Black Accountants (NABA), the North Carolina Association of Certified Public Accountants (NCACPA), The PhD Project, Delta Sigma Theta Sorority, Beta Alpha Psi and Beta Gamma Sigma. She serves the Greensboro community as an instructor in the Providence Baptist Church SAT Prep Program and a volunteer at the Doris Henderson Newcomers School. She is the faculty advisor of Beta Alpha Psi Zeta Sigma Chapter and was recognized as a 2016 National Faculty Advisor of the Year.
