



What is ChatGPT

- Chat Generative Pre-trained Transformer
- Fastest growing app in history
 - Launched November 30, 2022
 - 100 million users in two months
- > An Al chatbot
- Developed by OpenAl



History of OpenAl

- Research organization founded in 2015 by Elon Musk, Sam Altman and others
- Initially structured as a non-profit, now a forprofit entity
- Elon Musk resigned in 2018 due to conflict of interest with Tesla & SpaceX
- Microsoft announces \$10 billion investment in Jan 2023



Chatbot

➤ A program designed to simulate conversation with human users.



AI – Artificial Intelligence

➤ The development of "intelligent" machines that can perform tasks that typically require human intelligence, such as perception, reasoning, learning, and natural language processing.



Machine Learning

➤ Use of algorithms that enables machines to learn from data and make predictions or decisions based on what it has learned.



GPT - Generative Pre-trained Transformer

A type of language model that uses deep learning techniques to generate human-like text



NLP - Natural Language Processor

➤ A field of AI that deals with the interaction between computers and human language, enabling machines to understand, interpret, and generate human language.



LLM – Large Language Model

- ➤ An artificial intelligence (AI) model that is designed to generate human-like text.
- ➤ Trained on massive amounts of data, such as text from books, articles, and websites, and use complex algorithms to learn patterns in the data and generate text that is similar to human writing.



Where does it get its data?

- Public website data, including documents
- Private partnerships with entities
- Licensed from third party providers
- Crowdsourcing
- Sources are not always disclosed
- OpenAl provides an API for private company licensing using private data.
