

WHAT is a Custom GPT?

- A "custom GPT" is like having a personal assistant <u>tailored to help</u> <u>with a specific task, such as accounting research.</u> Imagine you're an accountant working on complex financial reports or needing to look up accounting regulations. A custom GPT designed for accounting would be specifically trained to help you with tasks like interpreting financial statements, explaining accounting principles, or quickly finding relevant accounting standards.
- Instead of being a general assistant that tries to do everything, this <u>custom GPT focuses on your accounting needs</u>, helping you save time and be more accurate with your research.


WHY use a Custom GPT?

Using a custom GPT is helpful because it's <u>specially designed to</u> <u>focus on exactly what you need.</u> Instead of being a general tool that knows a little about everything, a custom GPT is <u>like having</u> <u>an expert in a particular area</u>.

For example, if you're doing accounting work, a custom GPT for accounting would be trained to understand financial statements, tax laws, or regulations. This means <u>you get faster, more</u> <u>relevant answers to your specific questions</u>, saving you time and making your work easier.




Sometimes when people encounter ChatGPT, <u>they don't know where to</u> <u>start</u>. OpenAI calls it the "empty box problem." Discovering that led the company to find a way to narrow down the choices, Turley said.

"People really benefit from the <u>packaging of a use case -- here's a very</u> <u>specific thing that I can do with ChatGPT</u>," like travel planning, cooking help or an interactive, step-by-step tool to build a website, Turley said.



Ethical Considerations and Best Practices



Understand the Boundaries of AI in Accounting

- Excellent at assisting with routine tasks, report generation and providing quick answers to queries
- 2. Human judgement is still required!
- 3. Regulatory compliance stay aware

Best Practices:

- 1. Clearly define the roles AI vs Human
- 2. Regularly review and update for changes
- 3. Educate clients on how AI is used

"AI is neither good nor evil. It's a tool. It's up to the human race to ensure that AI is used for good."

Maintain Professional Judgment & Oversight

- 1. ALWAYS evaluate AI-generated outputs
- 2. All is a tool to inform decisions, not blindly accept
- 3. The accounting professional is ultimately responsible for the work

Best Practices:

- 1. Implement review process where AI-assisted work is checked by a professional.
- 2. Regularly conduct "AI audits" to ensure proper use

Biases in AI-Generated Content

- Data bias: When the training data is not representative of all scenarios
- 2. Regularly test AI outputs for unexpected patterns or disparities.

Best Practices:

- 1. Use multiple AI tools / cross reference with other methods
- 2. Provide training on recognizing AI biases




