- Intellectually disciplined process
- Conceptualizing ideas
- "Applying, analyzing, synthesizing, and/or evaluating information gathered from, or generated by, observation, experience, reflection, reasoning, or communication" (source: www.criticalthinking.org)
- Inductive Reasoning: "Bottom-up", specific examples used to derive general propositions
- Deductive Reasoning: "Top-down", general propositions deduced to specific examples

#### Who is the Public?

- "A distinguishing mark of a profession is acceptance of its responsibility to the public. The accounting profession's public consists of clients, credit grantors, governments, employers, investors, the business and financial community, and others who rely on the objectivity and integrity of certified public accountants to maintain the orderly functioning of commerce. This reliance imposes a public interest responsibility on certified public accountants. The public interest is defined as the collective well-being of the community of people and institutions the profession serves."

## AICPA Code of Professional Conduct

- "As professionals, certified public accountants perform an essential role in society. Consistent with that role, members of the American Institute of Certified Public Accountants have responsibilities to all those who use their professional services. Members also have a continuing responsibility to cooperate with each other to improve the art of accounting, maintain the public's confidence, and carry out the profession's special responsibilities for self-governance. The collective efforts of all members are required to maintain and enhance the traditions of the profession."

# Attuned to broad-based business knowledge

- CPA's and financial executives are being relied upon increasingly for greater insight into risk, strategy, and operations of the business
- COVID-19 exposed serious flaws in our supply chain, risk response, and manufacturing vulnerabilities
- The suddenness of the failure of FTX, Silicon Valley Bank, Signature Bank and concerns about deposit insurance and reserves reinforced the CPAs responsibility to understand the entire economic spectrum and to maintain the orderly functioning of commerce.

#### Professional skepticism

- "Independence of mind is the state of mind that permits a member to perform an attest service without being affected by influences that compromise professional judgment, thereby allowing an individual to act with integrity and exercise objectivity and professional skepticism"
- "Independence in appearance is the avoidance of circumstances that would cause a reasonable and informed third party who has knowledge of all relevant information, including the safeguards applied, to reasonably conclude that the integrity, objectivity, or professional skepticism of a firm or member of the attest engagement team is compromised"
- AICPA-CIMA Code of Professional Responsibility Section: 0.400.21

### Subordination of judgment

- Expanded standard to CPAs in industry and government as well as CPAs in public practice
- Expanded standard to include work done as a volunteer
- Proposes changing the subordination of judgment standard from "disagreement or dispute" to "difference of opinion"
- The concept of "substantial use of accounting" is gaining ground in the United States

#### What is Enterprise Risk Management?

- Enterprise risk management is a controlled, deliberate thought process which includes the entire organization to include the board of directors, management, and other personnel.
- ERM is applied in strategically, operationally, and tactically
- ERM is intended to identify potential events
- ERM is intended to manage risks within a level of risk tolerance
- ERM provides reasonable assurance strategically.

- SOC 1 SOC for Service Organizations: ICFR
- Report on Controls at a Service Organization Relevant to User Entities' Internal Control over Financial Reporting (ICFR) These reports, prepared in accordance with AT-C section 320, Reporting on an Examination of Controls at a Service Organization Relevant to User Entities' Internal Control Over Financial Reporting, are specifically intended to meet the needs of entities that use service organizations (user entities) and the CPAs that audit the user entities' financial statements (user auditors), in evaluating the effect of the controls at the service organization on the user entities' financial statements.

- There are two types of reports for these engagements:
- Type 2 report on the fairness of the presentation of management's description of the service organization's system and the suitability of the design and operating effectiveness of the controls to achieve the related control objectives included in the description throughout a specified period.
- Type 1 report on the fairness of the presentation of management's description of the service organization's system and the suitability of the design of the controls to achieve the related control objectives included in the description as of a specified date.
- Use of these reports is restricted to the management of the service organization, user entities, and user auditors.

- SOC 2® SOC for Service Organizations: Trust Services Criteria
- Report on Controls at a Service Organization Relevant to Security, Availability, Processing Integrity, Confidentiality or Privacy These reports are intended to meet the needs of a broad range of users that need detailed information and assurance about the controls at a service organization relevant to security, availability, and processing integrity of the systems the service organization uses to process users' data and the confidentiality and privacy of the information processed by these systems.

These reports can play an important role in:

- Oversight of the organization
- Vendor management programs
- Internal corporate governance and risk management processes
- Regulatory oversight

## Key Fiduciary Concepts – Fiduciary

A person is a fiduciary with respect to a pension benefit plan to the extent (i) he exercises any discretionary authority or discretionary control respecting management of such plan or exercises any authority or control respecting management or disposition of its assets, (ii) he renders investment advice for a fee or other compensation, direct or indirect, with respect to any moneys or other property of such plan, or has any authority or responsibility to do so, or (iii) he has any discretionary authority or discretionary responsibility in the administration of such plan. All such persons shall be guided by the prudent expert and/or the prudent person standard of care.

#### **Key Fiduciary Concepts – Duties**

- Undivided loyalty;
- Always putting the client's interests first;
- Utmost good faith and fair dealing;
- Full and fair disclosure of all material facts, and;
- Full and fair disclosure of all actual or potential conflicts of interest;

## Prudent Person and Prudent Expert

- Prudent Person operates with the care, skill, prudence, and diligence under the circumstances then prevailing that a prudent person acting in a like capacity and familiar with such matters would use in the conduct of an enterprise of a like character and with like aims;
- Prudent Expert the Prudent Expert Standard encompasses the standard fiduciary obligations outlined above, but in addition requires their application in a manner that an expert in the field would use.

3. Errors and pitfalls in critical thinking

## Enterprise Risk Management and the Accounting Profession

- Enterprise Risk without logical thought is haphazard at best
- The Accounting profession and Auditing standards reinforce enterprise risk as a basic concept

### Objectivity

- "Objectivity is a state of mind, a quality that lends value to a member's services. It is a distinguishing feature of the profession. The principle of objectivity imposes the obligation to be impartial, intellectually honest, and free of conflicts of interest."

#### Appeals to Pity

- Appeal to the compassion of society towards the "innocent"
- The elderly, children, veterans
- Politics and the media
  - Veterans benefits
  - Military spending
  - Education
  - Social Security/Medicare
- Have you ever been encouraged to do something unethical because the result would aid the "innocent"?

#### Argumentum ad Populum

- "Argument to the people"
- Is the majority always right?
  - "Bandwagon Fallacy"
- Ethical decisions may not be the popular decision.
  - Revenue Recognition issues
  - Many energy firms in the late 1990s (including Enron) booked revenue as a merchant instead of an agent
    - Grossly inflated revenue figures
    - BUT: energy firms did it to remain competitive

#### Argumentum ad Hominem

- "Argument against the man"
- Attack the motives/qualifications of the individual, not the actual decision or point-of-view.
- Politics and the media
- Bethany McLean & Enron
  - McLean was a journalist for Fortune magazine
  - In 2001, she questioned the valuation of Enron and how they even made money
  - Jeff Skilling publicly attacked her as "unethical" because she had obviously "not done her research"
    - NEVER ADDRESSED HER ACTUAL QUESTION

#### Reductio ad Absurdum

- "Slippery Slope Fallacy"
- Politics and the media
- Marketing

#### Mollification

- Downplaying past bad conduct or decisions by blaming problems on external circumstances.
  - "They were not ordinary times"
  - Everyone else was doing it
  - Competitive forces required it?

- Argument from Authority
  - Related to Argumentum ad Hominem
  - Position vs. qualifications vs. experience
    - Does Warren Buffett always make good investment decisions?
      - Or does his name give him leverage in today's investment negotiations? (Bank of America investment)
      - What about "The Buffett Rule"?
    - Meredith Whitney and financial projections.
  - Are people with experience or in positions of authority always ethical?

#### ■ The Gambler's Fallacy

- Independent events affect future outcomes.
- If something happens more frequently than normal now, it will happen less frequently in the future (balancing)
- Not getting caught in the past does not mean you won't get caught in the future.
  - How long did Bernie Madoff escape questions about his investment firm?
  - Acting unethically (or illegally) as a firm without negative consequences may mean you're just lucky (not right)

#### Sunk Cost Fallacy

- Common in business and government projects.
- Doesn't have to be related to financial costs.
- If you made one unethical decision, do you make another to cover it up?
  - If you made a mistake with a client, how do you react?
  - Ponzi schemes

## Critical Thinking Errors

#### Appeals to Tradition

- This is how we've always done things.
- Are traditions always ethical?
- Are the acceptable behaviors from 100 years ago still acceptable today?

#### Appeals to the New

- It's new, it must be better.
- But what are the second and third-order effects of this "new way"? Do we know the ramifications?
  - Financial Leverage & Derivatives

## Critical Thinking Errors

#### Confirmation Bias

- The act of favoring information that confirms your own beliefs.
- Ignoring information that refutes your beliefs.
- Standards of Objectivity?
- Have you ever ignored red flags or signs of financial/accounting fraud because you didn't want to believe they were true?
- "We don't see things as they are; we see them as we want them to be." Anais Nin (author)

4. Financial Capacity, and strategic partners

## **Financial Capacity**

- Financial Capacity is the representation by year of all available sources of funds.
- Financial capacity analysis includes a risk understanding of the likelihood of those funds being available.
- The sources of funds include:
  - Free Cash Flow
  - Working capital net of short term lines of credit used
  - Financing opportunities for fixed assets
  - Equity

### External Funds Needed

- The External Funds Needed model is a mathematical representation of the Statement of Cash Flows
- Incredibly easy to use
- Model's simplicity is the basis of a planning tool for cash needs
- Basic Premises include:
  - Growth consumes cash (use of funds)
  - Spontaneous assets and liabilities are directly correlated with growth in revenue
  - Net income is a source of cash
  - Dividends and capital spending consume cash
  - Debt service consumes cash

## External Funds Needed - Percent of Sales Method

$$EFN = \frac{SA}{S} \Delta S + \Delta FA - \frac{SL}{S} \Delta S - \Delta RE \pm MISC$$

- EFN = Amount of external funding to maintain its present condition
- SA = Increase proportionately as sales increase
- $\Delta S$  = Increase in sales that causes the need for external funding
- $\Delta$ FA = Required to meet increased demand
- SL = Increase proportionately as sales increase
- S = Existing sales level
- $\Delta RE = (S + \Delta S)(PM)(1 PO) \text{ or } (S + \Delta S)(PM) \$Div$
- MISC = Any other changes to the company's cash flow

### External Funds Needed

- Negative EFN represents "more than enough" funds available internally and with current capital to continue operations
- BUT negative EFN can become substantially positive within a short time frame
  - Prepare for the need for external financing when you CAN and not when you MUST – waiting until external funds are critical may lead to substantial increases in the cost of financing

- Developed to help companies properly and effectively evaluate the strategic and operational opportunities and risks
- Aids the CPA and financial executives in protecting the organization from unanticipated risks from a variety of sources:
  - Industry and economic trends
  - Customers
  - Suppliers
  - Competitors
  - Employees
  - Financial Institution relationships
  - Government regulators

- Industry and economic trend risks
  - Overall macro-economy
  - Industry group analysis
  - Pandemics
  - Loss of world currency status
  - Bankruptcy/insolvency of governmental units
  - Economic trends
    - Federal Reserve policy and the effect on interest rates
    - Unemployment
    - Business spending and investment
    - Long-term AND short-term trends

- Customer risks
  - Concentration of sales
    - Higher concentration drastically increases the risks to the company of a loss of a single customer
    - Loss of customer does not need to be customer service related; loss could come from a number of sources
  - Collectability of revenue
    - Related to concentration of sales
    - Increasing collectability issues could cause a firm to break debt covenants, increasing the cost of debt

- Suppliers and vendor risks
  - As with customers, a concentration of suppliers can pose significant risks to a company
    - Are there going concern issues with any suppliers?
    - How is your overall relationship with the vendor?
  - How are your suppliers perceived by the public and government regulatory bodies?
    - Legal issues against suppliers could affect your company
    - COVID-19 changed the perspective on supply chain vulnerabilities
    - Extreme events, while extreme, must be planned for regarding the impact on supply chain vulnerability and the impact on the survival of the organization

- Competitor risks
  - Most "obvious" risk to your market share
  - BUT what are your competitors really doing?
    - Competitor sources of financing and cost of capital
    - Other industries and business sectors
    - Corporate leadership
    - Acquisition history and excessive goodwill
      - Most mergers and acquisitions don't bring value to an organization

#### ■ Employee risks

- The loss of a key employee could devastate a growing business
- Attracting the right talent
- Retaining the right talent
- Employee engagement
- Impact of performance appraisals
- How effective is the HR Function?

#### Financial institution risks

- Banking relationships have been and will continue to be affected by Dodd-Frank and other financial regulatory reforms
- Effect of Tier 1 Capital ratios on lending
- Effect of leverage on the bank's own balance sheet
- Are you considered a higher risk in the eyes of the bank and regulators?
- Community banks and costs of regulatory compliance
- Lending in a post COVID-19 environment
- Beware of a liquidity trap due to pandemic

- Regulatory risk
  - Effect of court decisions on expansive authority of the EPA
  - U.S. DOT regulations and the impact on freight costs
  - Utility commission regulations in each state/municipality
  - Power of the states' Department of Health to create environment of life-sustaining versus non-essential business models and regulations
  - OSHA oversight and regulations
    - Employee thresholds

### Critical success factor

- A critical success factor is anything the presence or absence of which could cause the success or failure of the firm
- Tied deeply into the strategy of the organization
- Reflects the vision, mission, and strategy of the company
- Crucial to enterprise risk management and forecasting

#### Risk assessment

- Inherent and residual risks must be considered
- The probability of an event is crucial
- The impact of either a favorable or unfavorable event must be evaluated
- The correlation coefficient needs to be analyzed and validated
- Methodologies and techniques for risk assessment should be continuously reviewed

### Seminal Event

- A seminal event is one in which your actions at the time will have a significant effect on your life.
- How you respond will materially alter the rest of your life.
- You actions can be viewed as a crossroads
- Your response will follow you your entire life.
- The public is depending upon us
- Our family is depending upon us
- Our profession is depending upon us.
